Our Policy

Tuition Payment

Class sizes are limited. Payment in full is required to reserve your child's enrollment in a class. Space availability and enrollment will be confirmed in writing. Failure to make full payment may result in the loss of place in the class.

Discounts

La Casetta Rossa, LLC offers a 10% discount on tuition if enrolling for two (2) or more days per week and a 10% discount on tuition of each *additional* child enrolled from the same family. The first child enrolled pays full tuition.

Absence and Make-up Classes

Please call 24 hours in advance if your child will not be attending class. Classes are kept deliberately small, and each child's presence is important to the balance of the group. La Casetta Rossa, LLC allows two (2) make-up sessions per term. Make-up classes must be completed during the current term and will not carry over to the following term. Please call or email in advance to schedule a make-up class.

Withdrawal/Refund

In the case of withdrawal before the first three (3) days of your registered classes, you will receive a full refund minus a \$50 registration fee in the form of a check. In the unlikely event that you should need to withdraw after the first three (3) days of your registered classes, La Casetta Rossa, LLC offers a refund of 50% of the balance of remaining classes. La Casetta Rossa, LLC reserves the right to dismiss any participant if, in its opinion, this action is in the best interest of the program or the child. In the event of dismissal, the participant will receive a refund of the balance of remaining classes, minus a \$50 registration fee, in the form of a check.

Schedule Changes

La Casetta Rossa, LLC reserves the right to change class times. We will always notify you of any changes to the class to the best of our ability. All changes are communicated via email, so please make sure that you provide us with accurate contact information when you enroll your child in our program. La Casetta Rossa, LLC reserves the right to cancel a class due to insufficient enrollment or other circumstances beyond our control. Canceled classes will be rescheduled for the first available date. If a cancelled class is not rescheduled, participants will receive a refund for that class, in the form of a check.

Holidays and School Closure

Unless otherwise communicated, La Casetta Rossa, LLC will be open according to the Classes schedule posted on the company's website, including snow days and teacher in-service days. La Casetta Rossa, LLC will be closed during the Holidays posted on the company's website.
